Gentlemen:

On August 10, 1983, the Federal Energy Regulatory Commission (FERC) issued a Major License-Existing Dam to Arkansas Electric Cooperative Corporation (AECC) to construct and operate the Dam No. 2 Hydropower Project in Arkansas and Desha Counties near Dumas, Arkansas,

A Monitoring Plan was developed, filed and approved by your agency prior to initiating Project construction. The Monitoring Plan required that archaeological surveys be performed in different locations and at different elevations as excavation proceeded. The first Monitoring Report was filed with your office on September 6, 1994, and a response was received from your office dated September 19, 1994. The second Monitoring Report was filed with your office on October 11, 1994, and a response was received from your office dated June 6, 1995.

Monitoring was performed in the presumed location of the buried gravel bar, however the gravel bar was not specifically located and no artifacts were found at this location.

Attached are five (5) copies of the final Archaeological Monitoring Report which will be filed with FERC upon review and acceptance by the State Historic Preservation Office.



Dear Ms. Edwards:

My staff has reviewed both volumes referenced above regarding the cultural resources in the area of the proposed Arkansas Electric Cooperative Corporation Dam No. 2 Hydropower Project. We appreciate it that our previous concerns have been incorporated into these volumes. With the inclusion of the additional information, we are able to concur that no known historic properties will be impacted by the undertaking.

We also concur with the recommendation that monitoring is necessary in the area designated as "Zone 2." If cultural remains such as indian pottery, stone tools, old bottles or china are discovered during construction, this office should be notified immediately. These materials should be treated as specified in 36 CFR Part 800.11 of the Advisory Council on Historic Preservation's regulations. In addition should any human remains be discovered, work in the area should cease and an application for authorization to excavate (as per Arkansas Act 753) obtained from this office.
