The following provides additional information in support of the application for recertification of the Medway Hydroelectric Project as a low impact facility. In addition, the Lower Penobscot River Multiparty Settlement Agreement, the Medway Project FERC License, Water Quality Certificate, the National Marine Fisheries Service Endangered Species Act Biological Opinion, and the amendments to incorporate the relevant provisions of the Lower Penobscot River Multiparty Settlement are being provided separately.

#### A. Flows

The 2004 Lower Penobscot River Multiparty Settlement Agreement was incorporated into the license for the Medway Hydroelectric Project by amendment, including the pertinent water level and flow management measures and contingent mitigation requirements outlined in Attachments A and B of the Agreement. In addition, the Project's original license and Water Quality Certificate also include provisions for water level and flow management. Please see attached.

# B. Water Quality

The Medway Hydroelectric Project received its Water Quality Certification from the Maine Department of Environmental Protection on 23 December 1998, and the Certification was amended 18 April 2005 to incorporate the relevant provisions of the 2004 Lower Penobscot River Multiparty Settlement Agreement. Please see attached.

# C. Fish Passage and Protection

The 2004 Lower Penobscot River Multiparty Settlement Agreement, incorporated into the Project license by amendment, provided for fish passage and contingent mitigation requirements outlined in Attachments A and B of the Agreement. The license includes an article reserving FERC's authority to require the licensee to construct operate and maintain such fishways as may be prescribed by the Secretary of Interior or the Secretary of Commerce under Section 18 of the Federal Power Act. Under the 2004 Lower Lower Penobscot River Multiparty Settlement Agreement and the 2013 Order Amending License to Incorporate Terms and Conditions Under the Endangered Species Act requires the Licensee to consult with the fisheries agencies once every five years regarding the status of Atlantic salmon and project effects. Please see attached.

# **D.** Watershed Protection

Since the FERC Project boundary for the Medway Hydroelectric Project primarily contains the land necessary for operation and maintenance of the project facilities, state and federal resource agencies did not request a formal shoreland management plan. However, in addition to the standard FERC license requirements associated with erosion and sedimentation control, the Project is subject to federal, state and local erosion and sedimentation control requirements.

#### E. Threatened and Endangered Species Protection

The Medway Hydroelectric Project received the National Marine Fisheries Service (NMFS) Biological Opinion issued 31 August 2012 under Section 7(a)(2) of the Endangered Species Act for the federally-listed Atlantic salmon. The Biological Opinion recognizes that there are no fish passage facilities for anadromous fish and therefore upstream and downstream performance standards need not be met at the Medway Project. However, incorporated into the FERC license is a requirement for the Licensee to consult with the NMFS and the other fisheries agencies once every five years regarding the status of Atlantic salmon and other Endangered Species Act-listed fishery species in the Penobscot River to ensure that operation of the Medway Project is consistent with the listing determinations for such species and with the then-current recovery objectives for such species. Please see attached.

#### F. Cultural Resource Protection

Cultural resource assessments during the licensing process did not reveal any specific issues associated with the Medway Project. However, the Project does have a Cultural Resource Management Plan which includes provisions to address cultural resource issues in the event they arise during the term of the license.

#### G. Recreation

The Medway Hydroelectric Project license and Water Quality Certificate contain recreation-related provisions for the project. Black Bear Hydro Partners, LLC has implemented the recreation plan in accordance with the license requirements. Please see attached.

- (1) a 343-foot-long gravity dam, topped with 5.75 foot-high flashboards, with an impoundment elevation of 260.3 feet mean sea level (m.s.l.) with flashboards in place;
- (2) a 64-foot-long concrete gravity forebay wall;
- (3) a non-functioning upstream fishway;
- (4) a 101.5-acre impoundment at elevation 260.3 feet (normal impoundment level);
- (5) a 170-foot-long, 34-foot-wide, 71-foot-high brick powerhouse containing five generating units with a total installed capacity of 3.44 MW (plus 0.7 MW with additional proposed unit);
- (6) an approximate 144-foot-long, 3-kilovolt (kV) underground transmission line; and
- (7) appurtenant facilities
