



## SUBJECT - Low Impact Hydropower Institute (LIHI) North Shore Fishway Project Recertification Review

---

### BACKGROUND

Northern Wasco County Public Utility District (NWASCO) is headquartered at The Dalles, Oregon<sup>1</sup>. The North Shore Fishway Hydroelectric Project (NSFP or Project) is located at river mile (RM) 192 on the Columbia River in Klickitat County near Dallesport, Washington.

There are 60 dams in the Columbia River Watershed, averaging a major dam every 72 miles, with 14 being located on the main stem Columbia River. Many of the dams in the watershed were created for the primary purpose of producing electric power. Major construction began in the early 20th century and finished toward the end of that century. In addition to providing ample power for the Pacific Northwest, the created reservoirs provide numerous recreational opportunities, including fishing, boating, and windsurfing.

The NSFP is situated on the north shore of the US Army Corps of Engineers' (Corps) The Dalles Dam. The dam, with latitude and longitude of 45° 36' 44" N, 121° 8' 4" W forms the headworks for both the Corps hydroelectric development and the NSFP.

The Dalles Dam is an 8,875-foot long, 260-foot high, concrete-gravity run-of-the-river dam spanning the Columbia River with a drainage area of approximately 237,000 square miles. The spillway section of the dam is 1,380-foot long and has a discharge capacity of 178,000-cfs. Water is guided over the spillway by using up to 23 control-gates.

The Corps began work on the dam in 1952 and completed it in 1957. The construction of the dam submerged Celilo Falls, a cultural hub and fishing location of Native Americans in the region and created the reservoir named Lake Celilo. Lake Celilo runs 24 miles upstream to the foot of the John Day Dam (RM 216) and contains 330,000 acre-feet of gross storage with a surface area of 4,900 acres. Discharge from The Dalles Dam flows downstream to the Bonneville Dam at RM 146 on the Columbia River.

The Federal Energy Regulatory Commission (FERC) issued the Project a 50-year license (P-7076) on December 31, 1987<sup>2</sup>. An amended FERC license was issued on November 8, 1989<sup>3</sup> to allow for additional generating capacity, in compliance with Article 312 of the license<sup>4</sup>.

The Project consists of:

- A 210-foot-long, 20 foot-wide rectangular concrete intake channel connected to the auxiliary water supply system to the North Fishway fish ladder of the Corps Dalles Dam;
- 10-foot diameter, 85-foot long steel penstock;
- A 35-foot by 64-foot powerhouse containing one generating unit with an installed generating capacity of 4.9 megawatt (MW) at a design head of 80 feet and a hydraulic capacity of 800-cfs, and;
- A three mile long, 12.5 kilovolt (kV) transmission line.

The average annual energy output (AAE) from the project is estimated at 39,000 megawatt-hours (MWh). This corresponds to an annual plant factor of 90.8%. The energy produced by the Project is sold by NWASCO locally.

Prior to the construction of the Project, the entrance to the north fish ladder at The Dalles Dam received about 800-cfs of auxiliary water from the forebay through a rock channel. Water entering the system passed through a trash rack with  $\frac{3}{4}$  inch bars with a bar spacing of  $\frac{7}{8}$  inches. The trashrack kept adult fish and large debris from entering the auxiliary water system; however, juvenile fish still passed through the bars and ended up in the auxiliary water system.

The Project remedies this situation by requiring the separation of the smaller fish from the water that enters the turbine. The Project diverts that flow into a screened intake structure that separates the fish from the flow. The fish pass out the end of the intake structure and into a pipe that conveys them to the tailrace. The screened water is direct through a penstock to the turbine and then supplements the flow in the north shore fishway entrance.

Annual evaluation of fish passage based on the condition of sampled fish has occurred every year, except 2007, since the unit went on line in 1991, as stipulated in the FERC license. Annual reports include sampling activities for that year and summaries of previous years' data. The objective being to summarize the results of the fish sampling, both in quantity and quality of fish, relate that to performance of the bypass system, and to suggest improvements.

On April 21, 2011, the Project was originally certified by LIHI as the "North Shore Fishway Hydroelectric Project. – LIHI Certification No. 71", effective July 17, 2010 for a term of five years ending on July 17, 2015. On June 19, 2015 the LIHI certification was extended until December 31, 2015. LIHI received a complete application for a new term of Low Impact Certification for the Project on September 1, 2015.



## LIHI RE-CERTIFICATION PROCESS

Recertification review focuses solely on determining the answers to the following two questions:

- 1) Has there been a material change in circumstances since the original certification was issued?

For purposes of recertification review, a “material change in circumstances” will mean one or both of the following:

(a) Non-compliance: Since receiving its last certification from LIHI, the certificate holder/applicant has not implemented, or has delayed implementing, or has done an inadequate job of implementing obligations at or near the facility that are of relevance to LIHI’s criteria. These obligations could be in the form of terms and conditions of license(s), settlement agreements, resource agency recommendations or agreements, LIHI conditions of certification including annual notifications, agreements with local municipalities or other third parties or similar relevant obligations; or

(b) New or renewed issues of concern that are relevant to LIHI’s criteria: Since receiving its last certification from LIHI, either new issues of concern and relevance to LIHI’s criteria have emerged that did not exist or were not made known to LIHI at the time of certification, or there continues to be ongoing problems with previously known issues that appeared to LIHI to be resolved or on the road to resolution at the time of certification but in fact are not resolved, and are ongoing at the time of the re-certification application.

If a new license, settlement agreement, prescription, biological opinion or other similar regulatory decision has been made since the original recertification, these documents will be evaluated to determine if new or renewed issues have been raised.

- 2) Have any of LIHI’s criteria, or the Board’s interpretation of one or more criterion, changed in meaningful ways since original certification that are applicable to the circumstances of the facility seeking re-certification?

I reviewed the LIHI application to assess adherence to the LIHI certification criteria with the above in mind. NWASCO has stated that the operation of the Project has not changed since issuance of the LIHI certification in 2010 and they anticipate no changes in operation in the foreseeable future.

The prior certification of the Project was issued on July 17, 2010 and terminated on July 17, 2015 and has been extended to December 31, 2015. On September 1, 2015 LIHI received a complete application from NWASCO for an additional term of certification of the Project. LIHI posted the application for public notice on September 30, 2015, and the public comment period closes on November 30, 2015. Any subsequent public comments may be appended to this report.

A FERC e-library search was conducted to verify claims in the application. The docket search contains all Project documents. My review concentrated on the period from the start of the previous LIHI certification, approximately July 2010 through November 2015, for FERC docket number P-7076. Appendix A contains a reversed chronological list of docket items pertaining to this recertification.



On October 1, 2015, this reviewer emailed the agencies listed in the Project's Recertification application (National Marine Fisheries Service (NMFS)<sup>5</sup>, FERC<sup>6</sup>, Columbia River Inter-Tribal Fish Commission (CRITFC)<sup>7</sup>, Corps<sup>8</sup> and the Bonneville Power Administration (BPA)<sup>9</sup>).

In my email I stated, "... I am the LIHI reviewer tasked with determining whether the North Shore Fishway Project should be LIHI recertified. I am emailing you today because you have been identified in the application as resource agency and non-governmental organization contacts familiar with the project. I would appreciate your perspective regarding the project's proposed operation with regard to satisfying its licensed environmental obligations (FERC articles) and your views pertaining to the project being "low impact". Without your input my review can only be based on the documents found in the FERC docket. Thank you for your time in this matter. Please refer to the LIHI website for more details on the North Shore Fishway application and LIHI low impact criteria. <http://lowimpacthydro.org> ..."

Agency responses follow:

- Corps - On October 2, 2015 I received an email from Mr. Bob Cordie, Chief of Fisheries, stating, "... As project biologist at The Dalles Dam, I've had the opportunity to work closely with N Wasco PUD for the past 20 years. To the best of my knowledge, they have met the FERC obligations. They have been 'low impact' environmentally and operationally. They've always gone beyond what is required to assure best possible operating conditions for salmonid passage. They assure that all fishway operation criteria are met. They have assisted the Corps of Engineers on several occasions, with operation and maintenance. I recommend they are LIHI recertified.

No other comments have been received.

## RE-CERTIFICATION REVIEW

This section contains my review of the Project with regard to LIHI's certification criteria focusing solely on determining if there has been a material change in circumstances since the original certification was issued.

### LIHI Criterion-Flows and Pond Fluctuations

NWASCO and the Corps entered into a Memorandum of Agreement (MOA) for the operation of the NSFP on April 17, 1989. The MOA was approved by FERC on July 10, 1989.

Because the Dalles Dam was already in place, being managed by the Corps and since the NSFP requires a significantly small proportion of available river inflow (0.05% or less), the focus of the MOA was on maintaining the existing operational requirements as managed by the Corps. The MOA requires the NSFP to operate pursuant to the Corps discharge schedule and to obtain approval of any alteration to the release schedule from the Corps.

All downstream minimum flow requirements and reservoir elevation fluctuations are managed by the Corps and at their discretion, the NSFP receives about 800-cfs of auxiliary water from the main forebay through a rock channel. The NSFP is responsible for returning turbine discharge to the north shore fish ladder and maintaining optimum entrance conditions.

*Throughout the prior LIHI certification period, no non-compliance issues or areas of new concerns were found. Adherence to the above Flow and Pond Fluctuations standards has been maintained.*

### LIHI Criterion-Water Quality

The Dalles Dam has been identified as causing some negative impacts on the water quality in the Columbia River. However, only a small proportion (0.05% or less) of the Columbia River passes through the Project. Any potential water quality release requirements on the Columbia River in the vicinity of The Dalles Dam are the responsibility of the Corps.

Regarding the Project, on October 5, 1989, FERC issued an order approving a Soil Erosion and Sediment Control Plan (SESCP) pursuant to Article 401 of the license. The order referenced letters from the Washington Department of Ecology dated June 14, 1989, the NMFS dated July 14, 1989 and the USFWS dated July 24, 1989, indicating their acceptance of the plan. The methods proposed in the plan are adequate to control erosion, dust, and slope stability, and to minimize the quantity of sediment and other potential water pollutants resulting from project construction, spoil-disposal, and project operation and maintenance.

Because there is a potential for the Project to release lubricants into the river, the SESCO requires that the Project use an oil separator for internal drainage, and an oil sensor in the Project sump. After passing through the oil separator, the cooling water drains into the Project sump. If there is any oil in the water in the sump, operators are alerted by an alarm that requires using absorbent pads to remove any remaining oil. From the sump the water is pumped to the tailrace.



*Throughout the prior LIHI certification period, adherence to the above water quality standards has been maintained. No non-compliance issues or areas of new concerns were found.*

## LIHI Criterion-Fish Passage and Protection

Since the Project went on line in 1991, as stipulated in the FERC license, annual evaluations of passage conditions have been conducted every year except 2007<sup>10</sup>. Evaluations are based on the condition of the sampled fish; if they are uninjured, it is assumed that the bypass system is in good condition and passing fish safely.

A January 31, 2008 biological assessment was issued by FERC<sup>11</sup>, focusing primarily on the Project's fish sampling and monitoring program. For downstream passage, the Project maintains a screened auxiliary water bypass system to convey juvenile fish safely around the turbine. The condition of the screened bypass is monitored by sampling fish that have passed through it and evaluating their condition. This is done for one 24 hour period once a week from April through July. The bypass system for juveniles passes many "incidental" or riverine fish, such as bass and peamouth.

For upstream passage, the NWASCO is responsible for maintaining optimum entrance conditions at the north shore fish ladder using discharge from its turbine. Historically, the Corps maintained certain elevations and differentials at this fishway entrance as prescribed by its regional fish managers. The auxiliary water bypass system supplements the flow coming down the fish ladder to create the required differential at the entrance to the ladder. As part of the MOA agreement between the NWASCO and the Corps, the NWASCO assumed responsibility for maintaining required differentials at the north shore fish ladder entrance. The upstream fish ladder is primarily designed and works best for salmonids but riverine fish routinely use it.

As stated in NMFS' biological opinion and incidental take statement letter to FERC, dated December 19, 2011<sup>12</sup>, “ ... *After reviewing the current status of the listed species, the environmental baseline within the action area, the effects of the proposed action, and cumulative effects, it is NMFS' biological opinion that the proposed action is not likely to jeopardize the continued existence of the Snake River fall Chinook salmon ESU, Snake River spring/summer Chinook salmon ESU, Upper Columbia River spring Chinook salmon ESU, Snake River sockeye salmon ESU, Snake River steelhead DPS, Upper Columbia River steelhead DPS, or Middle Columbia River steelhead DPS, or to destroy or adversely modify their designated critical habitat. ...* ”

The estimated number of fish passing through the Project during the fish passage season is a small proportion of the total fish passing The Dalles Dam. The level of mortality was less than one percent of the average total runs from 2006 through 2010.

In a February 13, 2012 letter to NWASCO, the FERC<sup>13</sup> reviewed the “reasonable and prudent

measures” and “terms and conditions” identified in NMFS' 2011 biological opinion. FERC concluded that the NMFS requirements were being satisfied by the existing license and therefore no additional conditions requiring the FERC to amend the existing license or modify any requirements under Article 403 were necessary.

The Order Approving a Monitoring Plan for Intake Fish Screens and Fish Bypass System Design under Article 403, issued May 23, 1990<sup>14</sup>, requires NWASCO to file annual fish passage monitoring reports with the FERC by March 1 of each year. Furthermore, the order requires NWASCO to file, for FERC approval, any proposed changes to the sampling schedule or reporting schedule. Additionally, the Order Modifying and Approving Downstream Fish Bypass Facility Monitoring Plan, issued November 5, 2004<sup>15</sup>, require NWASCO to coordinate annually with NMFS, CRITFC, and the Fish Passage Center. All monitoring annual reports filed with the FERC by March 1 under Article 403 are provided to NMFS for review by December 31 of the previous reporting year.

*The Facility is in compliance with the fish passage and protection prescriptions. All annual reporting has been provided. Throughout the prior LIHI certification period, no non-compliance issues or areas of new concerns were found.*

## LIHI Criterion-Watershed Protection

There are no specific license articles or official agency positions with regard to watershed protection issues related to the Project. Resource agencies have not issued any recommendations, nor required the project to prepare any Shoreline Management Plan. Additionally, no documentation pertaining to any watershed protection issues at the Project were found in the FERC docket.

*A review of the Project indicates that during the prior LIHI certification period, the Project is not responsible for any compliance pertaining to watershed protection. Additionally, no new areas of concern have occurred.*

## LIHI Criterion-Threatened and Endangered Species

As previously discussed in NMFS' letter to FERC, dated December 19, 2011, it is NMFS' opinion that the proposed operation of the Project facilities is not likely to jeopardize the continued existence of the Snake River fall Chinook salmon ESU, Snake River spring/summer Chinook salmon ESU, Upper Columbia River spring Chinook salmon ESU, Snake River sockeye salmon ESU, Snake River steelhead DPS, Upper Columbia River steelhead DPS, or Middle Columbia River steelhead DPS, or to destroy or adversely modify their designated critical habitat.

*A review of the FERC docket indicates that during the prior LIHI certification period, the Project is in compliance with both state and federal resource agencies concerns pertaining to threatened and endangered species and that no new areas of concern have occurred.*

## LIHI Criterion-Cultural Resource Protection

In the FERC's 1987 Environmental Assessment it states that, " ... No properties have been identified in the project area as listed on or eligible for listing on the National Register of Historic Places ..." The document also references a December 12, 1983 letter from Robert G. Whitlam, the State Archeologist from the Office of Archeology and Historic Preservation, Olympia, Washington in support of this position. No other references pertaining to cultural resources protection were found.

*The Facility is in compliance with all requirements regarding Cultural Resources. A review of the FERC docket indicates that during the prior LIHI certification period, no new concerns pertaining to protection of cultural resources have occurred.*

## LIHI Criterion-Recreation

No recreational component has ever been recommended for the Project since the Project boundary is entirely inside the Corps' property and not accessible to the general public. The water intake is contained in the Boat Restricted Zone of the forebay so there is no access to the water immediately above the intake area. All recreational areas above and below The Dalles dam are managed by the Corps.

*The Facility is in compliance with all requirements regarding Recreation. A review of the FERC docket indicates that during the prior LIHI certification period, no new concerns pertaining to protection of cultural resources have occurred.*

## LIHI Criterion-Facilities Recommended for Removal

*A review of the FERC docket indicates that during the prior LIHI certification period, EBH does not have any facility that has been recommended for removal by a natural resource agency.*





**RECOMMENDATION**

*A review of the recertification application, additional documentation noted herein, public comments submitted in writing or other communications with resource agencies and other entities, and a FERC docket search for the current LIHI certification period has been conducted. I have concluded that no material changes or violations of required operations have occurred during this period.*

*I recommend that NWACO be issued a LIHI recertification for an additional five years for the North Shore Fishway Hydroelectric Project, FERC Dockets P-7076.*
